

TERMS OF USE

Prime Reserve Plus, Inc, including its successors and assigns, operating under the trade name “Minuteman VSC” (hereinafter referred to as “we,” “our” and “us”), offers consumers (hereinafter referred to as “you” and “your”) the ability, through your use of our technology partner, SeaPine Technologies, to receive free quotes for vehicle service contracts (“VSC” or “VSCs”) and purchase VSCs online. IMPORTANT: SeaPine Technologies is not a party to any contract with you. Their technology platform is intended solely for the purpose of providing quotes and allowing you to purchase the VSC you choose.

The VSC you purchase will include a contract which details the terms, conditions, coverages, benefits, exclusions, instructions on how to make a claim and any special state requirements of the VSC. The contract for any VSC you purchase will be between you and Prime Reserve Plus, Inc., and all the terms and conditions of the VSC will be available for you to read, review and print PRIOR to you making your payment on the VSC.

As an additional benefit, if you do not wish to purchase the VSC with a single lump sum payment, you will be offered during the transaction the ability to opt for a payment plan so that you can pay for the VSC over time. For your benefit, the payment plan providers will offer 0% financing with no credit check. Any payment plan you choose will be formalized in a separate contract between you and the payment plan provider.

After your transaction is complete, you will be sent all executed contracts via email to the email address provided by you. If you do not receive, or are unable to open/view, your contracts then please contact either Prime Reserve Plus, Inc. or payment plan provider to request the same. Therefore, it is very important that you use a valid email address during the process to best ensure successful delivery of your executed contracts.

We do not gather any personal information from you in order to provide you with initial VSC quotes. To receive a quote, you simply need to provide your vehicle information and the vehicle’s current mileage.

After choosing the plan, term and quote that you would like to purchase, you must then enter some personal information before finalizing the quote and purchasing the VSC. Such personal information may include your home address, phone number and email address. If you proceed with the purchase, we will also need to collect your debit or credit card information. At no point during the entire process will we ever ask you for your social security number or date of birth. Your personal information will be stored in our secure database and may be used only for purposes specifically enumerated in this Terms of Use and our Privacy Policy.
